WHEREFORE the parties have agreed as follows:

- Notwithstanding article 10.22, part-time faculty members shall exceptionally, for the 2021-2022 academic year, be permitted to obtain a second 3-credit course overload (the second overload must be an emergency overload) provided that:
 - The hiring process in article 10.19 and 10.20 has been completed;

- All qualified members from the Departmental Extract in which the overload is
 offered and who have yet to obtain a course overload per article 10.22 have first
 received the offer by order of seniority and declined it;
- The PTHC recommended the assignment of the 2nd overload;
- The Association has approved the assignment of the 2nd overload;

- 3. Notwithstanding the last paragraph of article 10.24 d), a graduate student who is not on the classification list who completed all their degree requirements may, with permission of the Association, receive regular part-time contracts if no candidates were found after the steps defined in article 10.19 and 10.20 of the Collective Agreement were completed;
- The present LOA shall come into effect on December 1, 2021 and remain in effect until April 30, 2022 and will only apply to courses pertaining to the 2021-2022 academic year;
- This Agreement shall be filed with the Minister within 60 days of its signing, pursuant to Article 72 of the Quebec Labour Code;
- The Agreement constitutes a transaction under article 2631, and following, of the Civil Code of the Province of Quebec and shall be governed by and interpreted and construed in accordance with the laws of the Province of Quebec;
